This service is not intended to be or replace medical advice. Upon their assessment, the clinical judgement of the dietician will inform the appropriateness of this service for Your condition. This service is available to those Members aged 18 and over only.

Dietitians cannot provide the service to patients who:

- have had bariatric surgery with complications post operation
- require enteral / parenteral or intravenous nutrition management
- are malnourished and at risk of refeeding syndrome- severe eating disorders
- have chronic kidney disease above stage 1 or with abnormal blood Potassium,
 Sodium, Phosphorus and Magnesium.
- have advanced complicated diabetes with amputations/ wound healing management.
- have advanced neurodegenerative conditions e.g Advanced Dementia or Alzheimer's with feeding difficulties
- have advanced stage cancer with cachexia

This virtual speech and language service gives you access to book remote video consultations with a speech & language therapist provided by HealthHero You can book an appointment to speak to a speech & language therapist via the online video service 08:00am to 20:00pm GMT, Monday to Friday (excluding Christmas Day and bank holidays). The booking is subject always to availability and may be cancelled or rescheduled at any time. This service is not intended to be or replace medical advice and any medical advice needed must always be sought by you in the first instance. Upon their assessment, the clinical judgement of the speech & language therapist will inform the appropriateness of this service for your situation. A Member is entitled to a maximum of 6 consultations for this service per calendar year. All minors must attend with a Member parent/guardian present for the entire duration of the video consultation. Patients need to be able to sit down and complete around 20-30- minutes of activities during the video consultation. Patients may be referred on to further services as usual depending on their requirements. This service is available to all Members aged from 2 years and over. Advice can also be provided to Parents for children of >1 and <2. Benefit available to members only. Suitability for online Speech and Language Therapy is made on a case-by-case basis.
